

# SYDNEY FESTIVAL

## Terms and Conditions

1. All information detailing how to enter this competition forms part of these Terms and Conditions. “We” or “our” refers to Sydney Festival, and “you” or “your” refers to an entrant. It is a condition of entry that all rules are accepted as final and that you agree to abide by these rules. The selection of the winners is final and no correspondence will be entered into. Submission of entry will be taken to mean acceptance of these Terms and Conditions.
2. If you are under 18 you must have your parent or guardian’s permission to enter.
3. The competition opens at 5:00pm AEST on Monday, 19<sup>th</sup> July 2021 and closes at midnight AEDT on Monday, 2<sup>nd</sup> August 2021. Any entry received after the expiry of the competition, or that is illegible, incomplete or defaced, will not be accepted.
4. To enter the competition, you must –
  - I) Clickthrough to the “Sydney Festival – Audience Survey about disability, access and inclusion” survey;
  - II) Enter in all mandatory / requested fields found in the survey;
  - III) Submit the completed survey; please note that submission of the survey means you have opted in and agree to the competition Terms and Conditions and Sydney Festival’s privacy policy.
5. You warrant that any details you provide with the entry are true and accurate and you indemnify Sydney Festival on a continuing basis against any loss or damage resulting from any breach of this warranty.
6. You will enter a pool where the winner will be chosen at random. The winner will be notified via email by midnight AEST on Monday, 16<sup>th</sup> August 2021.

The winner will receive the following;

- I) A \$250 dining credit at Reign in the QVB (located: Level 1, Queen Victoria Building, 455 George Street, Sydney 2000). We will manage the restaurant booking and liaise between the winner and the restaurant to find a suitable date. The credit must be used in one sitting, and any spend above the \$250 dining credit will be your responsibility.
- II) The dining credit must be used by Thursday, 30<sup>th</sup> of September 2021.

7. If we cannot contact a prize winner by midnight AEST on Monday 16<sup>th</sup> August 2021, we may determine another winner for the unclaimed prize. A winner of any unclaimed prize will be the prize winner for the purpose of these Terms and Conditions.
